


Figure 1 Trend in Patent Applications




Figure 2 Patent Applications by Residents and Non-residents




Figure 3 Numbers and Growth Rates of Patent Applications by Residents




Figure 4 Top 5 Patent Filing Countries (Regions) in 2021




Figure 5 Trends in Trademark Applications (by Case)




Figure 6 Trends in Trademark Applications (by Case and by Class)






Figure 7 Top 5 Trademark-Filing Countries (Regions) in 2021






